**TRI-STATE DWI / DUI VICTIM IMPACT PANEL**

The Court has ordered you to attend one session of the Tri-State DUI Victim Impact Panel. You are to complete this session within three months of your sentencing. You are to contact the Victim Impact Panel Coordinator at 712-255-6403 within ten days of sentencing to schedule the session. You will be required to pay a \$50.00 attendance fee. This fee is to be paid prior to the scheduled session and must be paid in **cash only**. It is your responsibility to let the coordinator know that written proof of your attendance needs to be sent to me. I strongly encourage you to call as soon as possible to make arrangements for scheduling this session, as the sessions have limited availability and they tend to fill up quickly.

**\*Failure to complete one session within three months of sentencing or provide written proof of attendance will result in a non-compliance report to the County Attorney.**
