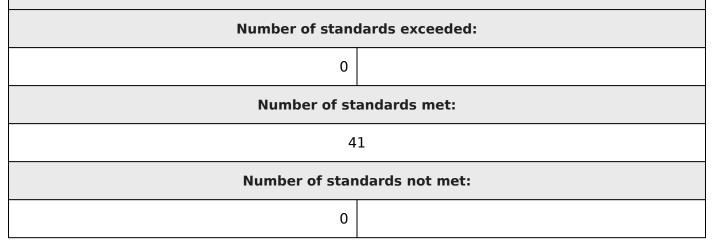

	The Gerald R. Hinzman Residential Correctional Center (Hinzman Center) is a community confinement facility in Cedar Rapids, Iowa operated by the Sixth District, Department of Corrections. The Iowa Judicial Districts as of July 1, 2023, came under the operational control of the Iowa Department of Corrections. The Iowa 6th Judicial District's PREA Policy 2400 follows the guidelines of the PREA standards. Throughout this report, this will be referred to as the "PREA policy". The PREA policy mandates zero tolerance for sexual violence of any kind.	
	The district is managed by the District Director. The Residential Manager manages the community residential centers within the district. The day-to-day center administration of Hinzman Center is managed by the Residential Supervisor who is tasked with maintaining PREA Compliance within Hinzman Center. The PREA Coordinator reports directly to the Residential Manager, is a senior-level staff and directly oversees the center's PREA efforts in concert with the center's Residential Supervisor. The Residential Supervisor works very closely with the administration and the PREA Coordinator. The PREA Coordinator and the Residential Supervisor have the time and the authority to carry out their PREA-related duties.

	The auditor interviewed the District Director, the Residential Manager, the Residential Supervisor, and the PREA Coordinator. The auditor reviewed the PREA policy, verified the staffing levels through the schedule that was provided, and verified through direct observation while on site. There are always two residential officers on each shift 24 hours a day. Typically, during the weekday there is one Residential Supervisor on duty. Additional staff include food service staff, a building maintenance worker, and a secretary.	
	The auditor reviewed the staffing plan that was completed. The Staffing Plan lists the staff and the resident numbers and physical layout. The staffing plan has been reviewed annually as required by the standard. There have been no deviations from the staffing plan. There are cameras located throughout the facility that aid in the supervision of residents but do not replace supervision. Cameras are considered a deterrent to sexual acting out and other safety violations and are used in post- incident investigations.

	Residential officers conduct rounds consistently throughout each shift. This is an all- male facility, and the female staff make an announcement when entering the housing wing. This was confirmed during the audit tour and through interviews with residents and with staff. The staff perform pat searches and do not perform strip searches or visual body cavity searches. However, if there were an exigent circumstance that warranted a cross-gender stirp search or body cavity search, with supervisor authority, the search would be documented in the cross-gender search log. The policy prohibits examination for the sole purpose of determining gender and staff are knowledgeable of correct search procedures as confirmed through	

interviews. Staff are adequately trained in searches of residents who are transgender or intersex, and such training is required by their policy. The restrooms have toilet stalls with doors. The showers are individual shower stalls, but they do not have shower curtains. The male residents stated they would like shower curtains on each shower stall for more privacy from other residents. Administrators state that they are working on procuring shower curtains for the shower stalls. As this standard only requires that the facility implement policies and procedures that enable residents to shower without female staff viewing them in a state of undress, the auditor cannot require this as a corrective action. However, the auditor was encouraged by the administrator's response that they would be purchasing these in the near future. Female staff do not enter the restroom unless they have verified first by an announcement that it is not occupied. Residents confirmed in interviews that female staff do not enter the restrooms when they are occupied. They may call out for a name during count from outside in the hall.

	The auditor reviewed the PREA policy, and interviewed administrators, and staff. The Hinzman Center will provide PREA information to all residents with disabilities including residents who are deaf or hard of hearing, those who are blind or have low vision, or those who have intellectual, psychiatric, or speech disabilities so that they have an equal opportunity to participate in or benefit from all aspects of Hinzman Center's efforts to prevent, detect, and respond to sexual have access to use the interpretive service for all communications other than day-to-day routine communication. There were no non-English speaking residents at the facility during the audit. All PREA-related documents for the residents including the posters, their training documents, and the handbook have a Spanish version, which is the language they primarily encounter other than English. The Hinzman Center will provide basic PREA information verbally to residents who are blind or visually impaired, and those who have intellectual, psychiatric, or disabilities. They provide written information to residents who are deaf or hard of hearing or if required, they will provide an ASL interpreter. The Hinzman Center has access to the Language Line for translation services through the lowa DOC but is currently using a list of lowa's State Court interpreter services.

115.217	Hiring and promotion decisions

Auditor Discussion

The auditor reviewed the PREA policy and reviewed a random sampling of employee files for the required documentation. The auditor interviewed the administrators and the Human Resources manager. The Hinzman Center hiring process includes the components required by this PREA standard. Law enforcement background checks are run upon hire. The human resources manager maintains a database of each employee's background check date and then has a monthly reminder to check for any of those hitting the five-year mark that will need to be re-run for that month. If the Hinzman Center utilizes any contractors, the Human Resources Manager runs background checks prior to utilizing their services. The facility asks questions directly about previous misconduct in written applications and in interviews for promotions. These questions are asked again annually of each employee through the annual evaluations as required by the standard. The facility checks with all previous institutional employers specifically regarding substantiated allegations of sexual abuse and provides documented evidence to support this. The agency provides information on substantiated allegations of sexual abuse or sexual harassment involving a former employee upon receiving a request from an institutional employer for whom such employee has applied to work.

The Iowa Department of Corrections (IDOC) policy AD-PR-11 IDOC General Rules of Employee Conduct paragraph 5 requires that all employees must inform their supervisor immediately if under investigation, arrested, charged, convicted, or required to appear in court for any criminal offense and that the District Director must be provided a written report with 24 hours of the occurrence. Paragraph 7 requires they report any sexual misconduct as described in standard 115.217 (a) (1) through (3).

	The auditor reviewed the Hinzman Center's PREA policy, and video monitoring systems, directly observed the facility, and conducted interviews with the District Director, the Residential Manager, the Residential Supervisor, and the PREA Coordinator. The facility considers the protection of residents and the standards when contemplating upgrades to the facility or in the application of technology. There have been no upgrades to the facilities. They have installed updated video monitoring technology and added additional cameras. They have camera systems in key areas. The camera systems are upgraded as needed throughout their service.

Auditor Overall Determination: Meets Standard

Auditor Discussion

The auditor reviewed the PREA policy and interviewed an investigator who conducts investigations. The auditor spoke with the Riverview Center which provides an advocate for accompaniment, and victim support services.

The auditor researched available services in Cedar Rapids, Iowa. The Cedar Rapid Police Department Sex Crimes Unit works closely with both Unity Point Health-St. Luke's Hospital and Mercy Medical Center in an effort to provide the highest quality of service to adult sexual abuse victims. Both St. Luke's Hospital and Mercy Medical Center have a Sexual Abuse Nurse Examiner (SANE) program in place to more efficiently provide services to victims of sexual abuse. The program complements a Sexual Abuse Response Team program, which has been established within the Cedar Rapids community. This team consists of individuals from the medical community, law enforcement, and various agencies in the community which all share a concern for the victim's welfare as well as the criminal investigation and prosecution of sexrelated crimes. If the resident is taken to the emergency room at St. Luke's or Mercy Medical Center, an advocate from Riverview Center will be called, and a sexual assault forensic examination will be conducted by a Sexual Assault Nurse Examiner (SANE). The Hinzman Center has a Memorandum of Understanding (MOU) with Riverview Center for these services. When law enforcement responds to a sexual assault case within the center, evidence protocol is followed, and they work cooperatively with the SANE to ensure all usable physical evidence is gathered.

115.222	Policies to ensure referrals of allegations for investigations

	Auditor Discussion
	The PREA policy requires the facility to refer all allegations for investigation. The Hinzman Center investigations are completed by qualified investigators and required documentation and reporting occurs. There are trained administrative investigators from the facility and criminal investigators from the Cedar Rapids Police Department available to investigate criminal allegations of sexual misconduct within the center. The administrative investigators have completed the Iowa Department of Correction's (IDOC) course PREA Investigator Training. Staff sexual misconduct may be investigated through an independent investigation conducted by the Iowa Division of Criminal Investigation if referred by the police department. The IDOC investigative policy can be found on the agency's website at https://doc.iowa.gov/prison-rape-elimination-act.

Auditor Overall Determination: Meets Standard

Auditor Discussion

The auditor interviewed the Residential Manager, the Residential Supervisor, the PREA Coordinator, and staff and reviewed training documentation. Newly hired staff have orientation training which includes the required components of this PREA training standard. Staff sign an acknowledgment form that they understand the requirements of PREA, the facility's zero-tolerance policy, and that they must immediately report any information or knowledge of sexual abuse or sexual harassment. New hires participate in training through the National Institute of Corrections (NIC) video PREA: Your Role Responding to Sexual Abuse, a review of the agency PREA policies, and some basic in-person training provided to them by the PREA Coordinator and other management staff. For refresher training by existing employees, they provide in-service training and policy review through various methods such as in-person training, training videos, and electronic training on their training online learning management system. On the online training, the staff are required to take a short test after each learning session to verify their understanding of the training material. Staff were knowledgeable in the required competencies such as the correct first responder response - separate, provide care, protect evidence, call for assistance, notify the supervisor,' and provide a written report.

115.232	Volunteer and contractor training

	The Hinzman Center volunteers and contractors are provided training in an online training session, and they take a test to ensure they understand the material they received. The auditor verified compliance with this standard through a review of training documentation, interviews, a review of the online training and quiz, and a review of policy.

	The Hinzman Center provides basic information to a resident during the intake process about the center's zero-tolerance policy and how to report. The information is presented to the resident during the intake process by going over key components of the handbook information and then requiring the resident to sign.

The resident also views the video "What You Need to Know" and signs an acknowledgment form. The handbook and the posters list the Iowa Ombudsman as the external reporting option. Hinzman Center staff review this information orally with residents with Iow literacy or comprehension levels or other disabilities or issues that may prevent them from learning this information on their own. PREA information is readily available throughout the resident's stay on posters and in their handbook. The auditor verified compliance with this standard through staff and resident interviews and by reviewing a sample of training documentation for residents.

115.234	Specialized training: Investigations

	Auditor Discussion
	The Hinzman Center has trained facility investigators to conduct administrative investigations. The administrative investigators have completed the Iowa Department of Correction's (IDOC) course PREA Investigator Training. All criminal allegations are turned over to the Cedar Rapids Police Department for investigation. The investigator works with others to form a coordinated response effort to include the SANE nurse and the advocates from the Riverview Center. Specialized training included techniques for interviewing sexual abuse victims, proper use of Miranda and Garrity warnings, sexual abuse evidence collection in confinement settings, and the criteria and evidence required to substantiate a case for administrative action or prosecution referral.

115.235	Specialized training: Medical and mental health care
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	There are no full or part-time medical or mental health care practitioners who work within the Hinzman Center. The resident chooses their private provider from those available within the community. Typically, Unity Point Health-St. Luke's Hospital and Mercy Medical Center. These facilities are also utilized by the facility in the event of a crisis, emergency, or sexual assault.

115.241	Screening for risk of victimization and abusiveness
	Auditor Overall Determination: Meets Standard

Auditor Discussion

The auditor spoke with the Residential Manager, the Residential Supervisor, the PREA Coordinator, staff, and residents, reviewed PREA policy, and reviewed resident screening documents. The Hinzman Center completes a screening process upon intake. It typically is conducted within the first few hours of intake, but not more than 72 hours upon arrival. The screening is objective and has all the required components as stated in the standards. The auditor reviewed a sample of resident reassessments that were conducted within 30 days of the initial intake. Residents who are transgender or intersex are reassessed at least twice each year. Residents are also reassessed if referred, requested by a staff member, there is an incident of sexual abuse or there is receipt of any other information that increases the resident's risk of sexual victimization or abusiveness.

115.242	Use of screening information

	Auditor Discussion
	The Hinzman Center's screening process is used along with other classification methods to determine placement within their housing areas. If the screening indicated this was necessary, there are enough housing options to keep residents separate. The placement of a resident who is transgender or intersex is determined on a case-by-case basis. The center considers the concerns of a transgendered or intersex resident's own view concerning his or her own safety. Those views are given serious consideration, and this was demonstrated through interviews with staff and residents. The facility does not place lesbian, gay, bisexual, transgender, or intersex residents in particular housing, bed, or other assignments solely based on such identification or status, nor does the facility consider lesbian, gay, bisexual, transgender, or intersex identification or status as an indicator of the likelihood of being sexually abusive.
	There is a restroom in each wing with toilet and shower stalls. The 400-wing at the Nelson Center is a smaller wing with a more private toilet and shower. Transgender residents would be afforded the opportunity to be housed in that facility to have more privacy for toileting and showering.

115.251	Resident reporting
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The auditor interviewed administrators, staff, and residents, reviewed the policy and

the resident handbook, and toured the facility. The Hinzman Center provides multiple external ways for residents to report sexual abuse and sexual harassment. Residents can call externally to family and friends, and call or write to the Iowa Ombudsman Office. The auditor called the Iowa Ombudsman from a resident phone. The phone did not require a resident's Personal Identification Number (PIN). The phone menu directs the caller to dial 1 to make a call (using a PIN) and dial 2 for the State Ombudsman. The auditor spoke with the Iowa Ombudsman Office, and they stated they would accept calls from this facility and allow the resident to remain anonymous upon request. They will instruct the resident on various ways how to report PREA-related issues to the Iowa Department of Corrections, but they will also take the report on the resident's behalf and report it to the PREA contact at their facility or to the Inspector General of the Iowa Department of Corrections. The Hinzman Center provides multiple internal ways for residents to privately report sexual abuse and sexual harassment, retaliation by other offenders or staff for reporting sexual abuse and sexual harassment, and staff neglect or violation of responsibilities that may have contributed to such incidents. They can report verbally to staff, write a grievance, call the internal PREA hotline that goes directly to the PREA Coordinator, and send an email to the PREA Coordinator. The auditor left a message using the payphone and selecting option 3 to make an internal PREA report to the District's PREA Coordinator. The PREA Coordinator confirmed that day that she had received the message. There is a posted list on the bulletin board near the phone that includes a free call list. This list includes the Cedar Rapid Police Department and other resources within the community that are free calls. They also can write directly to the District Director, use the facility grievance process, and write to the Victim and Restorative Justice Director for the Iowa Department of Corrections. Staff accept reports made verbally, in writing, anonymously, and from third parties and promptly document any verbal reports. Staff can privately report to any staff within their chain of command or outside of the chain of command to an administrator.

115.252	Exhaustion of administrative remedies
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The auditor reviewed the PREA Policy 2404-21, Grievance Policy 0116-22, the resident handbook, and conducted staff and resident interviews. The grievance policy section within the PREA policy regarding administrative remedies mimics the wording of Standard 115.252. The Grievance Policy 0116-22 states that the Residential Division Manager will ensure that the grievance process is included in the Resident Handbook.
	The Resident handbook states that the Hinzman Center does not impose a time limit on when a resident may submit a grievance regarding an allegation of sexual abuse. They do not require a resident to use any informal grievance process or to otherwise

attempt to resolve with staff an alleged incident of sexual abuse. They ensure that a resident who alleges sexual abuse may submit a grievance without submitting it to a staff member who is the subject of the complaint. They issue a final decision on the merits of any portion of a grievance alleging sexual abuse within 90 days of the initial filing of the grievance. Third parties, including fellow residents, staff members, family members, attorneys, and outside advocates, are permitted to assist residents in filing requests for grievances relating to allegations of sexual abuse and are also be permitted to file such requests on behalf of residents. They have established procedures for the filing of an emergency grievance when the resident is subject to a substantial risk of imminent sexual abuse. After receiving an emergency grievance alleging a substantial risk of imminent sexual abuse, the grievance is immediately forwarded to the Administrator for immediate corrective action, and provides an initial response within 48 hours, and issues a final decision within five calendar days. The initial response and final decision document their determination of whether the resident is at substantial risk of imminent sexual abuse and the action taken in response to the emergency grievance. The Hinzman Center may discipline a resident for filing a grievance related to alleged sexual abuse only where the administrator demonstrates that the resident filed the grievance in bad faith.

115.253	Resident access to outside confidential support services

	Residents have access to outside confidential support services. The facility has a Memorandum of Understanding (MOU) with the Riverview Center for advocacy and victim support services. The Resident Handbook lists under Victim Support Services the phone numbers for Riverview and the Rape Victim Advocacy Program. A resident may also place a free, unrecorded call by dialing 6 for the Riverview Center on the resident's payphone. If a resident dials 4 for Victim Advocacy, they will reach the Rape Victim Advocacy Program in Johnson County Iowa. This organization will also assist the victim by connecting them to a rape crisis counselor within their geographic area of Iowa. There are posters located throughout the facility and there is information within the Resident Handbook on ways in which residents can access victim support services. The auditor contacted the Riverview Center and RVAP to verify services.

115.254	Third party reporting

	Auditor Discussion

The lowa Department of Corrections website provides information on how an individual can make a third-party report. The IDOC website has a link titled Prison Rape Elimination Act (PREA) Information about PREA at Hhttps://doc.iowa.gov/ prison-rape-elimination-act/how-report-allegations-sexual-violence-idoc. This link directs third parties to report via email to PREA.reporting@iowa.gov , mail a letter to IDOC Central Office at 510 E. 12th Street, Des Moines IA 50319 or to the State of lowa Office of Ombudsman at 1112 E. Grand Avenue, Des Moines, IA 50319. Third parties can report sexual abuse and sexual harassment using these methods. Interviews with staff and residents confirm that staff and residents are aware that third-party reporting options are available. The Hinzman Center provides residents with reasonable and confidential access to their attorney. In addition, residents interviewed reported that they had contact with their families and others regularly who could report on their behalf.

	The facility PREA policy requires all staff to immediately report any knowledge, suspicion or information received related to sexual abuse/harassment incidents, retaliation and staff negligence that may have contributed to such incidents. Staff are required to make such reports to the PREA Coordinator or designee. All employees may privately report sexual abuse and sexual harassment of residents to their supervisor or any other facility supervisor or administrator. Random staff interviews confirmed their responsibility to report and to maintain that information in confidence. The PREA Coordinator, the Division Manager, or a designee will assign an investigator for all allegations of sexual abuse and sexual harassment, including third-party and anonymous reports. Staff interviews confirmed their responsibility to report and to maintain that information in confidence.

115.262	Agency protection duties

	The auditor reviewed the PREA policy, and interviewed the staff and the administration. The facility requires all staff to take immediate action to protect the resident from imminent sexual abuse. All staff understand that "immediate" means when the response is needed – that could mean within minutes if the abuse were recent, or it could mean before the end of the shift for incidents in which an abuse was reported that occurred in the distant past. There have been no reported incidents over the past 12 months in which immediate protection measures were

required because a resident was subject to a substantial risk of imminent sexual abuse.

115.263	Reporting to other confinement facilities

	Auditor Discussion
	Interviews with staff confirm that action will be taken upon receiving an allegation of sexual abuse while a resident was at another facility and will notify another agency if a resident at this facility reports a sexual abuse allegation that may have occurred at another facility.
