Electronic Device Usage Form
(First 3 Rules are for all Probationers/Parolees regardless of offense)

- Register ALL **electronic devices** including but not limited to: PCs, notebooks/laptops, tablets, smartphones, gaming devices, smart TV's and storage devices to which I have access with the Sixth Judicial District Department of Correctional Services. I will agree not to use any of the aforementioned devices not registered with the Sixth Judicial District Department of Correctional Services. I agree to report when I purchase, sell, replace or remove any registered device.
- Probationer/Parolee consents to unannounced examination by Probation/Parole Officer of any and all PCs, notebooks/laptops, tablets, smartphones, gaming devices, smart TV's or other electronic devices to which probationer/parolee has access for the limited purpose of detecting content prohibited by this document, conditions of probation/parole or court order. This consent includes access to all data and/or images stored on any storage media whether installed within a device or removable and separate from the actual electronic device.
- Social Media, Instant Messaging (text, voice, and/or video), Internet Message Forum, Interactive Gaming Systems and Internet file storage use is prohibited until registered with DCS and Sex Offender Registry. Use of these platforms must be in accordance with their terms of service.

- All User ID's and passwords shall be submitted to my Probation/Parole Officer and/or law enforcement officers upon request.
- Due to the nature of my offense, I am prohibited from accessing social media, or using the internet unless approved by probation/parole officer and/or Sex Offender Program Treatment Team.
- I understand I am required to install and pay for internet monitoring software such as RemoteCOM; I will abide by the monitoring agreement.
- Probationer/Parolee understands and agrees that using any electronic device (anything requiring an internet identifier) for any purpose which might further sexual activity is strictly prohibited without approval by Probation/Parole Officer. Such use includes, but is not limited to, the following: Possession of sexually explicit material in any form/sexually related "chat" or email exchange; visiting or joining "chat rooms" which contain sexually explicit conversations; visiting/viewing sexually explicit material on web sites; websites that contain nudity or sexually explicit conversations.
- Probationer/Parolee will not own or possess any **cameras** including but not limited to: Polaroid, Instep cameras, camcorders, digital cameras, camera phone, virtual reality goggles, or web cameras unless given specific approval from the Sex Offender Treatment Team.

— Probationer/Parolee will not delete or alter browser history data without prior approval by probation/parole officer.
