The IDOC-7th is pleased to announce the development of a High Risk Unit of Probation/Parole Officers with the support of community stakeholders. The High Risk Unit (HRU) is a special public safety unit established within the Department. All of this unit's officers and the Supervisor will be Certified Law Enforcement Officers. They are the only Department staff certified and allowed to carry weapons. This unit performs a large number of vital functions for the District and the community including:

- Support department programs (i.e., field and residential units, GVI, Specialty Courts)
- Conduct checks in all five counties of the district
- Ensure clients are complying with the conditions of supervision
- Detect violations and identify or introduce interventions before new victims are created
- Execute warrants and apprehend absconders
- Partner with and collaborate with local law enforcement including the U.S. Marshal Task Force by information sharing, special projects, etc.
