\*\* Nonrefundable ticket purchased by the responsible institution and forwarded with gate and clothing allowance. Residence plan must indicate immediate return to Iowa upon parole or discharge.

\*\*\* The winter season normally will be November 1 through March 31. The summer season normally will be April 1 through October 31. Exceptions by approval of Warden/Superintendent or designee.

\*\*\*\* Transportation allowance will not be issued if the offender does not provide a residence plan.

\*\*\*\*\* Offenders in other jurisdictions who do not parole or work release or discharge back to Iowa will not receive a transportation allowance.

\*\*\*\*\* If released to INS detainer, all monies owed to the offender, including current account balance, shall be given to the transporting authority at the time of release.
